Your personal data will be stored for the period resulting from the general provisions of law, in particular Act of 14 July 1983 on the national archival resource and archives and from the Ordinance of the Prime Minister of 18 January 2011 on office instruction, consistent itemised file lists, and instructions on organizations and scope of operations of company archives.

Your personal data is processed in accordance with Article 6(1)(e) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). The legal basis for your personal data processing is the Resolution No XXI/231/11 of the Kraków City Council of 6 July 2011 on establishing prices and fees for transport services, eligibility for reduced fees, and tariff regulations for Kraków city transport realized in the territory of the Kraków Municipality and Cities and Communes which had signed the intercommunal agreements on local public transport, appendix no 3 (Legal Journal of the Małopolska Voivodeship item 2011.363.3101, as amended).
